1. Consent to Receive SMS Messages

By signing this agreement, I, _____, voluntarily consent to participate as a beta tester for the SMS AI Assistant service provided by Draconis Systems LLC.

I understand and agree to the following:

1.1 Message Types

I will receive automated SMS messages containing:

- AI-generated responses to my text messages
- Service notifications related to beta testing
- Technical updates or system status messages

1.2 Message Frequency

- I will receive one immediate "Thinking..." acknowledgment per message I send
- I will receive AI-generated responses (typically within 30-120 seconds)

2. Beta Testing Expectations

As a beta tester, I agree to:

- Report any technical issues or errors encountered
- Suggest improvements to enhance the service
- Allow collection of usage metrics for testing purposes (message count, response times, error rates)

I understand this is a beta test and:

- The service may have bugs or unexpected behavior
- Features may change without notice
- Service availability is not guaranteed during testing
- My feedback may influence the final production version

3. Data Collection and Privacy

3.1 Information Collected:

- My phone number
- Content of SMS messages exchanged with the AI assistant
- Conversation timestamps and message counts
- Technical metadata (response times, error logs)

3.2 Data Usage:

Collected data will be used solely for:

- Providing the AI assistant service
- Testing system performance and reliability
- Improving AI response quality
- Developing the production version

3.3 Data Retention:

- Active conversation history: Stored indefinitely in encrypted Redis database
- You may delete at any time using the **/clear** command
- Upon opt-out: Deleted within 7 days
- Service logs (non-content): Retained for 90 days for technical troubleshooting
- Signed consent forms: Retained for 3 years per TCPA requirements

3.4 Privacy:

My data will not be:

- Sold to third parties for marketing
- Shared beyond necessary service providers
- Used for purposes other than providing this service

3.5 AI Privacy:

All messages are processed by OpenAI's ChatGPT-4.1 service to generate responses. OpenAI's data usage policy: <https://openai.com/policies/privacy-policy>

I understand that:

- My messages are sent to OpenAI's servers for processing
- OpenAI may use conversation data per their terms of service
- Draconis Systems LLC uses OpenAI as a data processor

3.5 Current AI Model

As of the effective date of this agreement, the SMS AI Assistant uses OpenAI ChatGPT-4.1 (gpt-4.1-2025-04-14). Draconis Systems LLC may implement additional or alternative AI models during the beta test, including but not limited to:

- Anthropic Claude (various versions)
- Google Gemini (various versions)
- OpenAI GPT-4.5, GPT-5, or successor models
- Other frontier AI models as they become available
- Hybrid systems using multiple AI models

If we change the primary AI model, we will notify you:

- Via SMS at least 7 days before the change (for material changes)
- With information about the new model and its data handling practices
- With a link to the new provider's privacy policy
- With the option to opt out if you do not wish to use the new model

4. Opt-Out Rights

4.1 How to Opt-Out:

I can stop receiving messages at any time by:

- Texting any of these keywords: **STOP**, **UNSUBSCRIBE**, **CANCEL**, **END**, or **QUIT**
- Contacting Draconis Systems LLC directly to request removal

4.2 Opt-Out Effect:

Upon opt-out:

- I will receive a confirmation request asking **YES** or **NO**
- After confirming **YES**, I will receive one final confirmation message
- My phone number will be removed from the active users list
- No further messages will be sent unless I complete a new consent form
- My conversation history will be deleted within 7 days

4.3 Re-Subscribing:

If I opt-out and later wish to rejoin the beta test, I must provide new written consent.

5. Service Identification

All messages from the service will clearly identify the sender as "SMS AI Assistant" or "Draconis Systems LLC."

7. No Warranties

7.1 AI Service Limitations:

I understand that:

- The AI assistant (ChatGPT-4.1) may provide inaccurate information
- Responses should not be relied upon for medical, legal, or financial advice
- The AI does not have real-time information or internet access
- The AI may occasionally produce inappropriate or unexpected responses
- Conversation history is limited to optimize performance

7.2 Response Times:

- Typical response time: 30-120 seconds
- Complex queries may take up to 2 minutes
- Service may be slower during high usage periods
